As a growing not-for-profit organization that is focused on delivering compassionate care, Hospice Vaughan is seeking two candidates interested in serving on our Board of Directors in a volunteer capacity.

Qualified candidates will have previous experience serving on a Board of Directors, and/or serving on a Hospice Vaughan Committee. Hospice Vaughan Board of Directors is proud to reflect the diversity and vibrancy of our community by seeking community-minded leaders, particularly with knowledge of and experience in Finance & Audit, Governance, Health Care, Public Affairs, Marketing and Communications, Strategic Planning and Operations Management.

The term of the appointment is 3 years beginning October 2020 with an option for a second 3-year term.

Applications must include a CV together with a letter setting out reasons for the candidate's interest in serving on the Board and ways in which the candidate believes they can support Hospice Vaughan, its staff, volunteers and those we serve in the community. CVs and letters of interest should be no longer than 3 pages total.

Board candidates should be:

- willing to advocate for Hospice Vaughan and champion its issues;
- a strong team player
- prepared to engage and focus on Hospice Vaughan's needs
- prepared to attend regularly scheduled Board meetings and other meetings as required
- an active participant on one or more Hospice Vaughan Committees
- willing to attend events and activities sponsored by Hospice Vaughan

Organizational Overview:

Since 1995, Hospice Vaughan, a not-for-profit organization, has been providing compassionate support to individuals facing a life-limiting illness or the loss of a loved one. We provide in-home visiting volunteers, a day program and grief and bereavement support. Our services extend out to caregivers, family members and friends who also need support in their time of need and grief. All our programs and services are free of charge for individuals of all ages. With a volunteer base of more than 120 volunteers we offer a visiting volunteer program supporting more than 500 individuals in the community. Our trained staff work with caregivers, community agencies and health care professionals, to offer services in the community and at our Woodbridge Centre. The need for residential hospice beds is acute and Vaughan currently has none. Hospice Vaughan is committed to building a fully integrated and comprehensive Centre of Excellence for the delivery of Hospice and Palliative Care that includes 10 residential beds for end-of-life care.
